The USPS has the most disabled veterans employed there of any federal agency. It would reduce services and impact senior citizens. She would like everyone to call our Senators and Congressional leaders and show our support to keep the USPS a federal agency.

Scott Glassmeyer 4267 Clifford ave. He works for the US Fish and Wildlife Service. He wants council and citizens to be aware of the changes that could be happening, He and many others may lose employment due to reduction in work force. This will impact employees and the environment. He has asked Dr. Jetter if he can office in the building since it is a government role.
